

**ACTIVE4ME PARENTAL CONSENT FORM
(Children Under the Age of 13)**

Active4me is working with your child's school [and] [insert third party organization if applicable (the "program administrator")] to help encourage a healthy lifestyle. In order for your child to register an account with us and take full advantage of the Active4me system, we must first obtain your consent as a parent or legal guardian.

Active4me, in cooperation with your child's school [and the program administrator identified above], will collect and use the following information about your child: name; user name; teacher name/classroom; grade level; gender; round trip distance to and from school; method of transportation to and from school; and certain physical activity, e.g., laps run or walked, performed while at school. We collect this information from you, your child, [the program administrator identified above,] and authorized school administrators, directly and through our website. Your child will receive his/her own unique barcode ID that can be scanned by school personnel when your child arrives at school and we will keep track of distances that your child has walked/biked. Other than our third party service providers (such as our hosting service), your child's name will not be shared with any third parties. Your child's user name, gender, teacher/classroom, grade level, method of transport to and from school, and certain statistics (trips to and from school, total distance traveled, related estimates of environmental and monetary/fuel cost savings) will be shared on his or her school "mini-site," which is accessible only with a unique password assigned by the school's program administrator and provided to students, parents, teachers and any other personnel authorized by the school. You may review the information and ask to have it deleted, and prevent future collection and use of information, at any time by contacting us. We do not require children to disclose more information than is reasonably necessary to participate in our service.
